Universal and Regional Highlights

- FORTHCOMING HEARINGS OF THE INTER-AMERICAN **COURT.** The Inter-American Court of Human Rights will hold. between January 24 and February 9, 2024, its 164th Regular Session. Which will be developed in a hybrid way, combining inperson and virtual activities. The public hearings and the Opening Ceremony of the Inter-American Judicial Year 2024 will be broadcast through the Court's social networks. Among the main activities, the Court will hold public hearings in the following Contentious Cases: Case of Ubaté and Bogotá v. Colombia; Case of Reyes Mantilla et al. v. Ecuador; Case of Aguirre Magaña v. El Salvador: Capriles v. Venezuela Case: Case of Galetovic Sepunar and others v. Chile; and Case of Muniz Da Silva et al. v. Brazil.
- FORTHCOMING JUDGMENTS OF THE EUROPEAN COURT. On 23 and 25 January 2024, the European Court of Human Rights will announce judgments and decisions in writing for five cases. On the 23rd, the Court will address two cases: "O.G. and Others v. Greece," involving eleven Greek nationals contesting the nonconsensual release of their HIV-related medical data, and "O.R. v. Greece," where an Afghan minor, O.R., challenges his living conditions and lack of legal guardianship in Greece.

The rulings on 25 January will cover three additional cases: "Dimitrova v. Bulgaria," "Rousounidou v. Cyprus," and "Diethnis Akadimia Agios Kosmas O Aitolos v. Greece." These cases relate to various human rights issues, including privacy, inhuman treatment, and procedural concerns. The decisions and press releases will be available on the Court's website and can also be accessed through its online database HUDOC.

- ICJ CONCLUDES FIRST HEARINGS ON SOUTH AFRICA'S **GENOCIDE CASE AGAINST ISRAEL.** On January 11 and 12, 2024, the International Court of Justice (ICJ) concluded public hearings on a request for provisional measures filed by South Africa against Israel. The case pertains to the alleged violation of the Genocide Convention in Gaza. South Africa's delegation, led by Ambassador Vusimuzi Madonsela and legal advisor Cornelius Scholtz, requested urgent interim measures to protect the Palestinian people, citing the Genocide Convention. Their demands included immediate suspension of Israeli military operations in Gaza, prevention of actions that could lead to genocide, and ensuring no disruption to Palestinian access to essentials like food, water, and healthcare. Israel, represented by Deputy Attorney General Gilad Noam and others, asked the Court to reject South Africa's request and remove the case from its docket. The case originated from a December 29, 2023, filing by South Africa, accusing Israel of breaching obligations under the Genocide Convention regarding Palestinians in Gaza. The ICJ, the principal judicial organ of the UN, will now deliberate and announce its decision in a future public session. The Court's press releases are for information purposes only and are not official documents.
- WORLD NEWS IN BRIEF (UN NEWS). On January 18, 2024, UN Secretary-General António Guterres expressed deep concern over escalating military tensions between Iran and Pakistan, marked by reciprocal airstrikes. Iran's initial strikes in Pakistan and Iraq targeted Sunni terrorist camps, which followed an ISIL suicide bombing in Iran's Kerman city. Pakistan's response included precision strikes near the Iranian border. Both sides reported casualties, including women and children, with Iran urging restraint to preserve Tehran-Islamabad relations. Concurrently, a UN-appointed team began investigating war crimes in Sudan, focusing on sexual violence and child military recruitment.

In healthcare, the WHO released guidance on using generative AI, like ChatGPT, emphasizing the importance of managing risks like bias and misinformation.

Finally, UN human rights chief Volker Türk highlighted the need to integrate human rights into the global financial system, proposing reforms for sustainable development and better handling of economic crises post-COVID-19.

UN URGES THE U.S. TO HALT EXECUTION BY **ASPHYXIATION.** On January 16, 2024, the UN Office of the High Commissioner for Human Rights (OHCHR) expressed serious concerns over the planned execution of Kenneth Eugene Smith in Alabama, set for January 25. This execution, involving nitrogen gas asphyxiation, would be the first of its kind in the United States, OHCHR warned that this method could constitute torture or other inhumane treatment under international human rights law. The office urged Alabama to halt the execution, highlighting that Smith's case still has unresolved proceedings in federal court. Additionally, the protocol for nitrogen asphyxiation in Alabama does not include prior sedation, a practice even recommended for euthanizing large animals. The OHCHR stressed the death penalty's inconsistency with the right to life, lack of evidence for deterring crime, and risk of executing innocent individuals. The office advocates for a moratorium on capital punishment as a step towards its universal abolition.
